## MINUTES OF THE TASK FORCE MEETING BAYVIEW HUNTERSPOINT ENVIRONMENTAL JUSTICE RESPONSE TASK FORCE Wednesday, April 19, 2017

The Bayview Hunters Point Environmental Justice Response Task Force convened the monthly meeting at the Southeast Community College, Alex Pitcher Room at 1800 Oakdale, Bayview Hunters Point, San Francisco, California on the above date at 2:15pm.

- I. Welcome and introduction of participants Brian Butler of Greenaction welcomed Community Partners and Residents to the meeting.
- II. Agenda Review No changes or corrections to the agenda. Bradley Angel announced Marie Harrison absence would be extended several months due to a medical condition and will send well wishes and will provide an update her progress.
- III. IVAN Reports Bradley Angel reviewed 16 IVAN complaints filed around illegal dumping, foul and rancid odors, animal waste, dust & pollution in the air and truck idling. He reviewed the status and updates submitted on pending reports. The Air District responded to complaints online. Roger (Dept. of Toxic Substance) commented on over 157 reports filed through the Task Force and the good analytics that is provided. Brian Butler of Greenaction pointed out the direct connection to the outreach and more utilization by communities in addressing problems. The goal is to find a way to continue the task force.
- IV. Presentation: Department of Toxic Substance Control Provided an overview of the Community Protection Hazardous Waste Initiative. Goal is to develop and launch a pilot project with partners to help with framework. Thorough presentation held 4/20 public open meeting to voice concern and ask questions. Bradley provided background on DTSC, Low Income Spanish speaking communities, government agencies and allies. Greenaction mandated a stop to dumping on communities. Announcement on massive expansion permit was given. Bradley stated his appreciation for their efforts. Overview of what will be included in Initiative include: Project History Detail, Topics on Waste, research on Senate Bill 14 (SB14) Improve pollution reduction activities. Meeting information is posted online and will also be provided to Bradley Angel to share with Task Force meeting attendees.
- V. Presentation: BUILD & Parks and Rec The San Francisco Recreation and Parks Department (RPD) and BUILD, cosponsors of the proposed India Basin mixed-use project, provided a summary of the development plans of the project located at 700 and 900 Innes Ave. Presentation included site history and details on the use of the 38.84 acre combined project site. 14.2 acres are owned by RPD and consist of parks, passive open space, and a dilapidated former boat yard, 7.52 acres are public Right-of-Ways owned by DPW, and 17.2 acres are owned by BUILD. BUILD is proposing to develop 1,240 residential units and approximately 275,000 gsf of commercial/office/institutional/flex space and over 11 acres of new and improved open space.

RPD is proposing to improve over 6 acres of existing parks and create over 2 acres of new parkland on the shoreline, completing the missing piece of the 1.5 mile continuous shoreline band in India Basin. The Draft EIR will be posted on indiabasinsf.com when it becomes available in June. A handout of the site plan was distributed by the project director. Discussion included site plan, public access, community engagement, transportation plans, and the proposed public shuttle with connection to BART and Caltrans as an interim process. Further discussion to continue at May 17 Task Force Meeting with look at results, requests for handouts and answers to questions raised. Any additional questions for Build and Parks & Rec are to be sent to Brian Butler of Greenaction.

VI. **Public Comment & New Pollution Complaints** – There were no additional pollution complaints filed.

## VII. Announcements

- The Task Force is seeking funding for future efforts, including outreach, staffing, meetings and food. The current grant will end in July.
- On April 21st, there will be an Earth Day Action. Flyers for the event were provided. All in attendance was encouraged to share this event within their network and on social media.
- Thanks to SF Enviro for \$2,000 donation that is split between daytime and evening meeting outreach. Currently submitting request for proposals and renewals. Currently seeking additional funding to continue Task Force.
